- b. COMMERCIAL: \$90.00 base rate which includes the first 5,000 gallons per month and \$13.00 per 1,000 gallons hereafter
- c. DEPT OF HEALTH: \$ 1.00 safe water fee applied to every residential & commercial accounts.

Bill due date is the 15th of the month. On the 16th a 10% late fee is applied.

Payment must be received by MAIL & in the P.O. Box by the close of business on the 19th or delinquent fee \$35.00-\$75.00 will be applied & disconnected on the 20th.

Delinquent Fee is determined by how many times you have been late over the years: 1st - \$35.00 *2nd- \$40.00 *3rd- \$45.00 *4th- \$50.00 *5th- \$75.00 + past due amount

The bill is mailed on 3/26/XX, so the current bill service dates are 2/15/XX to 3/15/XX, with a due date of 4/15/XX.
